

# SIT30622 CERTIFICATE III IN HOSPITALITY

## Food and Beverage

NITA's hospitality traineeship is aimed at young Aboriginal and Torres Strait Islander people who have a desire to work in the Australian hospitality industry. Throughout this traineeship, students will develop a wide range of industry skills and knowledge that will help to progress their hospitality career. It includes learning about hospitality service overall, a sound knowledge of general industry operations, food and beverage service and an in-depth knowledge of hospitality operations across Ayers Rock Resort (ARR).

This qualification targets those eligible for a traineeship and who are currently employed as an entry level worker by Voyages, with a demonstrated interest in an ongoing career within the hospitality sector. This qualification is also the base for the graduating trainees to transition into a number of career paths and other sectors of the industry, which will, for most occupations require further accredited training, such as: tourism and tour guiding, reception, housekeeping and administration.

*Entrants into this NITA course, designed specifically for Voyages' ARR, are typically:*

- Those with an interest and basic knowledge of working in the hospitality sector.
- Newly employed persons by Voyages, who are eligible to undertake a contracted traineeship.
- From an Aboriginal and Torres Strait Islander background.
- Young people aged between 18-30 years old.
- Those for whom English is not necessarily their first language.

To support the appointment of each person into the traineeship, and in accordance with NITA's Application and Enrolment Policy and Procedure, NITA's Recruitment Team assesses each applicant's suitability against the following. The applicant must possess:

- Basic core skills inclusive of language, literacy and numeracy (LLN).
- Have an understanding of working within the hospitality sector (ascertained at pre-enrolment screening and interview and verified through the orientation program).
- A level of independence and maturity to successfully live and work in a remote location away from their families and networks, and
- A minimal/basic level of computer navigation and research skills.
